Health Needs Assessment/Evidence Review

- Refresh/review of data

Baseline Variations Audit of Specialist CAMHS

- Comprehensive audit of CAMHS
- Understanding of services provided
- Highlighting variations of practice & good practice
- Using funding wisely to deliver sustainable improvement
- Workforce planning



Additional Funding

- Additional recurring investment of £7.65m
- Improve access, ensuring equity with waiting times for AMHS & paediatric services:
 - urgent CAMHS referrals within 48 hours
 - routine CAMHS referrals within 28 days
 - neurodevelopmental services within 26 weeks
- Further investment announced 31 March 2016
 - **£1.1 million** for peri-natal mental health

• £325,000 for transitional/recovery workers in EIP teams
