## Part 1- Local Primary Mental Health services:

- Open access community based groups.
- Certain practitioners are not able to undertake assessments.
- Support for GPs and primary care staff remains a priority.
- A clear interface between primary and secondary services critical.

# Part 2: Care Co-ordination and Care and Treatment Planning

All areas in Wales report compliance.

Over 90% have a Care and Treatment Plans.

 Support for those involved in ensuring the quality of plans and the interventions required to support them.

 Evaluated by service users, service providers and independent bodies.

# Part 2: Care Co-ordination and Care and Treatment Planning

Review of eligibility to undertake the care coordination role and the actual words care and treatment plan.

# Part 3: Re-accessing services post discharge

- Those discharged from secondary mental health services must be aware of the discharge plan and method of re access to services.
- Services will need to ensure they have robust procedures in place to support timely re-access for assessment.

# Part 4: Expanded Independent Mental Health Advocacy:

- The provision of the expanded IMHA services reported by all as positive.
- Clarity on the process of engaging an IMHA for those who may not have the capacity.
- Information regarding the impact upon service users and carers both in terms of satisfaction and outcomes.
